# **Summary of Change**

CAM Regulation 200-4 Installation Hunting and Fishing

This is a full revision dated 15 July 2020 –

- Inserts the Summary of Changes into the regulation.
- Moves the regulation approval signature to the front of the regulation IAW DA PAM 25-40.
- Inserts history, summary, applicability, proponent and exception authority, Army Management Control Process, supplement, suggested improvements, and distribution paragraphs as a precursor to the table of contents IAW DA PAM 25-40.
- Changes the name of CAM Regulation 200-4 from "Installation Hunting, Fishing, and Outdoor Recreation" to "Installation Hunting and Fishing".
- Makes Chapter 1 the Introduction including Purpose, References, and Explanation of Abbreviations and Terms. Adjusted all other chapter numbers accordingly.
- Removes all language regarding outdoor recreation activities (i.e., horseback riding, camping, hiking, wildlife watching, and cycling sections). Outdoor recreation activities will be addressed in a separate policy letter.
- Removes Appendix B Hunting Seasons and Bag Limits for purposes of annual update on iSportsman and made Appendix B Fort Campbell Hunting and Fishing Permits.
- Removes Appendix E Quail Hunting Procedures for purposes of annual update on iSportsman.
- Adds authority for the Senior Commander to open the cantonment area to hunting as needed. Verbiage allows for additional restrictions to ensure safety and mission requirements are meet.

- Adds "Area capacities are published on the Fort Campbell iSportsman web portal <a href="https://ftcampbell.isportsman.net/RegulationsandForms.aspx">https://ftcampbell.isportsman.net/RegulationsandForms.aspx</a>" paragraph 2-4b.
- Removes permit exemption for seniors and members of the WTB (Warrior Transition Battalion), paragraph 2-4l.
- Adds the verbiage "No person shall" to all portions of the regulation prohibiting specific actions.
- Adds prohibition to "Commit violent and abusive behavior toward DPW employees", paragraph 2-7.
- Adds verbiage to allow exceptions for hunters to take photographs of harvested animals at unrestricted hunting locations, paragraph 2-10h
- Changes "use of drones of any type is prohibited" to "No person shall use drones or unmanned aerial vehicles of any type during any type of hunting, fishing, of any type. Drone usage at Fort Campbell is restricted or governed by other regulations promulgated by the Federal Aviation Administration, Department of Defense, the U.S. Army or Fort Campbell", paragraph 2-10i.
- Adds "No person shall enter Fort Campbell from private property for hunting, and fishing activities", paragraph 2-10j.
- Changes person to issue revocation of privileges from Chief, Environmental Division to DPW Fish and Wildlife Program Manager, paragraph 2-12b
- Adds that suspensions of 60 days or less cannot be appealed, paragraph 2-12b.
- Adds that suspension or revocation of 90 days can be appealed within 10 days of notice, paragraph 2-12b.
- o Adds provisions for the use of centerfire rifles, paragraph 3-1a.
- o Changes "Appendix B" to "visit <u>www.ftcampbell.isportsman.net"</u>, paragraph 3-2a.
- Includes new state laws banning use of natural deer urine scents, paragraph 3-2f
   All other requirements were moved down in alphabetical order by this adjustment.
- Adds "wanton waste" regulations, paragraph 3-2p.

- Changes verbiage for clarification that a temporary transport tags are required for transporting deer, paragraph 3-3a (3).
- Adds provisions for use of centerfire rifles for hunting in designated areas, paragraph 3-3a (5).
- Adds that hunters hunting in authorized "Gun" areas must meet state requirements of 500 square inches of blaze orange, paragraph 3-3a (6).
   Following requirements were adjusted to this sequential order.
- Changes verbiage for clarification that a temporary transport tag is required for transporting turkeys, paragraph 3-3b (2).
- Omits "Non bearded (without a visible beard) turkeys may be harvested on any authorized "Archery Only" deer hunt", paragraph 3-3.
- Changes verbiage for clarification of proper check-in method for fall turkey hunters hunting in groups, paragraph 3-3b (7).
- Changes verbiage for clarification of proper check-in method for "caller companions" for turkey hunting, paragraph 3-3b (8).
- Removes allowance to harvest feral hogs on authorized big game hunts, paragraph 3-3c (3).
- Combines previous sections in paragraph 3-4 to provide clarification of regulations governing use of calls for purposes of coyote and bobcat hunting, and included citation to hunting seasons and bag limits being found on iSportsman Portal.
- Changes verbiage to clarify that quail hunters must submit a harvest report during check-out procedures, paragraph 3-4c (1).
- Adds "Quail hunters must wear a fluorescent orange hat (at minimum) while quail hunting on Fort Campbell" to increase safety, paragraph 3-4c (5).
- Changes verbiage to provide clarification for check-in procedures for rabbit hunters hunting in parties, paragraph 3-4d (2).
- Adds "Rabbit hunters must wear a fluorescent orange hat (at minimum) while rabbit hunting on Fort Campbell", paragraph 3-4-d (5).

- Changes verbiage to provide clarification for check-in procedures for squirrel hunters hunting in parties, paragraph 3-4e (3).
- Changes verbiage to provide clarification for check-in procedures for waterfowl hunters hunting in parties, paragraph 3-4f (2).
- Removes possession limits. This information is no longer applicable and is redundant. Following requirements were adjusted to this sequential order, paragraph 3-4f (4).
- Changes verbiage to provide clarification of legal shooting hours for waterfowl hunting, paragraph 3-4f (5).
- Changes verbiage to provide clarification to handicapped hunters regarding requirements to have handicapped parking placard or vehicle registration while hunting in handicap hunting areas, paragraph 3-5a.
- Adds information of proper check-in procedure for those individuals wishing to assist handicapped hunters, paragraph 3-5e
- Combines regulations 2-6.c-e to provide clarification regarding requirements of Youth Hunters being accompanied by adults and appropriate check-in procedures, paragraph 3-6c-d.
- Removes "no person shall swim in any water on Fort Campbell, paragraph 4-1j.
   Following requirements were adjusted to this sequential order.
- Adds the locations and procedures for the use of boats, kayaks, and canoes for fishing activities, paragraph 4-1r.
- Changes verbiage to clarify that dog trainers may pursue raccoons only before and after Spring Turkey Season, paragraph 5-1a (1).
- o Includes authorization for resource collection in areas open for hunting and game scouting with appropriate permit and area assignment, paragraph 5-2b.
- Adds the collection of firewood and removed wording limiting the collection of other forest products to what will fit in a 3-pound coffee pot, paragraph 5-2d.
- o Adds collection of firewood in accordance with CAM Reg. 200-2, paragraph 5-2e.

- Removes regulation restricting shed antler collection to 1 pair daily. Added "requires a permit authorizing deer hunting" for purposes of shed antler collection, paragraph 5-2f.
- Changes price of annual fishing permit from \$15 to \$20, Appendix B.
- Removes all sale of all outdoor recreation permits. This will be addressed in a separate policy letter, Appendix B.
- Removes Appendix B "Hunting Seasons and Bags Limits" to allow hunting seasons and bag limits to be set annually. Following appendices were adjusted to this sequential order
- Removes all references to outdoor recreation. Outdoor recreation will be addressed in a separate policy letter. Appendix C.
- Adds permanent revocation of privileges for "Purposely failing to retrieve harvested game (wanton waste)", Appendix C.
- Adds permanent revocation of privileges "Violent, threatening, and abusive behavior to DPW employees", Appendix C.
- Adds 6 month suspension for "Use of unauthorized ammunition". Appendix C.
- Reduces participating in hunting and fishing without valid permit or license from a
   2 year suspension to a 6 month suspension. Appendix C.
- Adds 30 day suspension for "Failure to properly tag game prior to transportation",
   Appendix C.
- Adds 30 day suspension for "Any other violation of laws and regulations mentioned in CAM Reg 200-4", Appendix C.
- Adds 30 day suspension for "Parking more than 35 feet from any authorized road" and "Driving on any authorized road", Appendix C.
- Adds Warning for "Failure to complete check out procedures (1st offense), Appendix C.
- Adds 15 day suspension for "Failure to complete check out procedures (2<sup>nd</sup> offense), Appendix C.

- Adds 30 day suspension for "Failure to complete check out procedures (3<sup>rd</sup> and subsequent offenses) Appendix C.
- o Adds POW Camp Road as a closed road. Appendix D.
- o Adds "(TA14)" to Mataya Road to provide clarification, Appendix D.
- Adds "Amie Lehman Trail (except for waterfowl hunters during waterfowl season with area assignment to hunt TA19 beaver pond)", Appendix D.

**History.** This publication is a full revision including major changes to formatting, chapter numbers, and content. The portions affected by this revision are listed in the summary of changes.

**Summary.** This document prescribes policies, responsibilities and procedures for hunting and fishing on Fort Campbell Military Reservation (Fort Campbell or FCMR).

Applicability. This document is punitive in nature and applies to all military personnel, their family members, civilians, customers, partners, and contractors who perform duties, reside, utilize facilities, and/or enter and travel on the installation. Penalties for violating any of these provisions include the full range of statutory and regulatory sanctions, both criminal and administrative, and do not preclude prosecution of military personnel under other regulations, provisions Article 92, Uniform Code of Military Justice (UCMJ), or other laws, when such prosecution is appropriate. Violations by civilian employees may be the basis for appropriate disciplinary action and civilian offenders may be removed from this installation, denied re-entry, and prosecuted for violating the exclusion order.

Proponent and Exception to Authority. The proponent for this regulation is DPW; ATTN: IMCB-PWE. The proponent has the authority to approve exceptions or waivers of this regulation that are consistent with controlling laws, regulations, and Fort Campbell policies. Activities may request a waiver to this regulation by providing justification that includes a full analysis of the expected benefits and must include formal review by the activity's senior legal officer. All waiver requests will be endorsed by the commander or senior leader of the requesting activity and forwarded through their higher headquarters to the policy proponent.

**Army Management Control Process.** This regulation does not contain management control provisions.

**Supplement.** Supplementation of this regulation by subordinate commanders is prohibited without prior approval from this headquarters.

**Suggested improvements.** Users are invited to send comments and suggested improvements on DA Form 2028 (Recommended Changes to Publications and Blank Forms) via email to <a href="mailto:harold.t.riggins.civ@mail.mil">harold.t.riggins.civ@mail.mil</a> who will coordinate the action with the regulation proponent.

**Distribution.** This regulation intended for major units, subordinate units, directorates and agencies assigned or attached to this installation. # Chapter 1 Introduction

#### 1-1. Purpose

To establish responsibilities, policies and procedures for hunting and fishing on Fort Campbell.

#### 1-2. References

Required and related publications and prescribed and referenced forms are listed in Appendix A.

### 1-3, Explanation of Abbreviations and Terms

Abbreviations and terms used in this regulation are explained in the Glossary.

# Chapter 2 General

#### 2-1. State and Federal Laws

- a. All persons participating in hunting and fishing activities on Fort Campbell will comply with State and Federal fish, game, and natural resources laws, all Army and Fort Campbell regulations, and will cooperate fully with representatives of law enforcement agencies. All firearms brought onto the installation will be registered with Directorate of Emergency Services (DES) Visitor Control Center (VCC) IAW Army Regulation (AR) 190-11, Fort Campbell Regulation (CAM Reg) 190-1, and CAM Reg 200-4.
- b. In addition to appropriate permits issued through the Directorate of Public Works (DPW) Fish and Wildlife Program for hunting and fishing on Fort Campbell, individuals must possess valid licenses issued by Tennessee or Kentucky for each game species pursued. Kentucky requires different licenses based on species being hunted, and Tennessee requires different licenses based on weapon being used (e.g. muzzleloader license for deer, gun license for deer, archery license for deer). Depending on which state you obtain your state licenses through, be sure they complement the weapon and species you will be pursuing on Fort Campbell.
- c. An approved state hunter safety certification is required for all hunters of all ages in order to obtain a hunting permit through the DPW Fish and Wildlife Program.
- d. All firearms brought onto the installation will be registered with the DES VCC in accordance with (IAW) AR 190-11 and CAM Reg. 190-1. **Note: Firearms will not be transported inside the VCC building.** Civilians must print and bring the applications form, Fort Campbell Form (FC Form) 2635 (obtain through iSportsman web portal <a href="https://ftcampbell.isportsman.net/RegulationsandForms.aspx">https://ftcampbell.isportsman.net/RegulationsandForms.aspx</a>) to the VCC for processing. IAW AR 190-11, chapter 4-5 and AR 190-13, chapter 8, non-Department of Defense ID card holders will be required to obtain a one-day pass for a hunting permit and favorably pass a criminal background check annually. A visitor pass and weapons permit will be required to obtain a hunters permit.
- e. A Migratory Bird Permit and Federal Duck Stamp are both required, in addition to appropriate permits sold by the DPW Fish and Wildlife Program, to hunt waterfowl on Fort Campbell.

f. A Migratory Bird Permit is required, in addition to appropriate permits sold by the DPW Fish and Wildlife Program, to hunt woodcock on Fort Campbell.

#### 2-2. Responsibilities

- a. Senior Commander (SC) of Fort Campbell is responsible for fish and wildlife management, and the hunting and fishing programs at Fort Campbell. He has delegated management authority for these programs to the Garrison Commander (GC). The SC retains the exclusive approval authority for use of normally restricted areas for hunting and fishing purposes to include the cantonment area. Such areas will be specifically designated and released as determined by the SC IAW applicable laws and regulations. Additional restrictions and limitations may be implemented to ensure safety and mission requirements are meet.
- b. The GC has delegated the authority to plan, coordinate, and implement fish and wildlife management IAW AR 200-1 and the Integrated Natural Resources Management Plan (INRMP) to the Director of DPW. The Director of DPW has further delegated the responsibility for fish and wildlife management to the Conservation Branch, Fish and Wildlife Program Manager.
- c. The hunting and fishing program is administered through Fort Campbell DPW Fish and Wildlife Conservation Branch.
- d. Fort Campbell Fish and Wildlife (FCFW) will perform the administrative functions necessary to assign hunters and fishermen to available areas on Fort Campbell.
- e. The DPW Fish and Wildlife Program Manager is authorized by the GC to suspend and/or revoke hunting and fishing permits for violations of the policies and/or procedures prescribed in this regulation.
- f. The DPW Fish and Wildlife Program Manager serves as the approving official for all requests by hunters with disabilities for special hunting considerations. The DPW Fish and Wildlife Program Manager may be contacted at (270)798-9854.
- g. The GC has delegated authority to the Installation Provost Marshal Office (Chief of Police) as the Chief of the game wardens for enforcement of hunting and fishing laws and regulations, and for military, federal, state, and local police support in the Rear Area of Fort Campbell. Game wardens and law enforcement personnel may be contacted at (931)472-8730 (Lead Officer).
- h. The GC has delegated authority to Directorate of Plans, Training, Mobilizations, and Security (DPTMS), Range Division Chief, to release training areas for hunting and fishing use.

# 2-3. Eligibility

- a. The SC has authorized members of the general public limited access to Fort Campbell for purposes of hunting and fishing in compliance with the Sikes Act (16 USC 670a-f) and under terms of the INRMP. Authorized patrons are set forth in AR 200-1.
- b. Primary use of Fort Campbell is for military use. Hunting and fishing opportunities may become available only after military requirements are met. This is no guarantee that areas will be available for hunting and fishing activity on any given day

.

#### 2-4. Authorized Activities and Permits

- a. Before engaging in any activity not listed below, please contact the DPW Fish and Wildlife Program Manager for guidance concerning the permissibility of activities on Fort Campbell and need for a permit and/or area assignment. Permissible activities on Fort Campbell are separated into three categories: hunting, fishing, and other consumptive and non-consumptive activities.
- b. Opportunities for recreational use of natural resources will be available to all eligible persons within the quotas established by the DPW Fish and Wildlife Program Manager. Area capacities are published on the Fort Campbell iSportsman web portal <a href="https://ftcampbell.isportsman.net/RegulationsandForms.aspx">https://ftcampbell.isportsman.net/RegulationsandForms.aspx</a>. The Federal Government is not responsible for any injuries or liabilities incurred by any person while engaging in hunting and fishing activities. All persons requesting hunting and fishing privileges must complete a hold harmless agreement acknowledging the government's limited liability prior to issuance of a permit (included in the online iSportsman application process).
- c. Appropriate permits must be obtained by individuals prior to participating in any hunting or fishing activities. Access to any area on Fort Campbell must be appropriately permitted for safety purposes. This includes cemetery visits.
- d. Available permits and their associated fees are located in Appendix B. Additional permit fees or application fees for lottery drawings; such as those for white-tailed deer, turkey, and waterfowl; may be required due to high permit demand or management costs. Permit fees may be changed at any time by the approval of the Fort Campbell GC.
- e. Proof of a valid Tennessee or Kentucky hunting and/or fishing license is required prior to issuance of permits by the DPW Fish and Wildlife Program. Patrons must have appropriate state licenses and permits prior to hunting and/or fishing on Fort Campbell.
- f. Proof of successful completion of an approved state hunter safety course is mandatory before individuals participate in hunting activities on Army land.
  - g. Proof of weapons permit issued by Fort Campbell DES VCC is required.
- h. Proof of a visitors pass for hunting permit to validate a favorable criminal background check issued by Fort Campbell DES VCC IAW AR 190-13, chapter 8 is required.
- i. Annual permits issued by the DPW Fish and Wildlife Program for hunting and fishing are valid from 1 March through the last day of February of the following year.
- j. Active Duty hunters who have become disabled have access to an Active Duty Disabled Hunting Permit. This permit will allow them access to handicap hunting areas.
- k. Permits must be purchased through DPW Fish and Wildlife Program iSportsman <a href="https://ftcampbell.isportsman.net">https://ftcampbell.isportsman.net</a>.
  - I. Free Fort Campbell hunting and fishing permits are issued to:
- (1) Disabled veterans who possess a valid Disabled Veteran Hunting License from the state of Kentucky or Tennessee.
- (2) Youth, 9-17 years of age, who possess a state approved hunter safety certification and appropriate Tennessee or Kentucky state licenses and/or permits.
- (3) Active duty military on leave carrying leave papers are issued free hunting and fishing permits. Hunter safety certification, weapons registration, and appropriate area assignment are required.
  - (4) Active duty military personnel in pay grades E1 through E4.

### 2-5. Authorized Hunting and Fishing Days

Hunting activities are authorized from Thursday through Monday (closed on Tuesdays and Wednesdays). All hunting and fishing activities will be closed on **Thanksgiving Day**, **Christmas Eve**, **Christmas Day**, **New Year's Day**, **and Easter**. Hunting seasons and bag limits are posted on the iSportsman web portal. All seasons and bag limits are subject to change. Fort Campbell and FCFW reserves the right to close all activities on any given available date for any necessary reason.

#### 2-6. Vehicle Control

- a. All vehicles must be driven directly to and from the assigned area.
- b. Vehicles with unchecked game are prohibited to exit Fort Campbell.
- c. Privately owned vehicle (POV) operations on Fort Campbell is restricted to authorized roads only (see Appendix D for list of unauthorized roads or visit the Fort Campbell iSportsman portal for a detailed map on authorized and unauthorized roads).
- d. POVs must be parked on Fort Campbell in the area assigned and within 30 feet of an authorized name roadway. Use of adjacent private property is prohibited for all individuals participating in hunting and fishing activities.
- e. Off-road use of any vehicle type is prohibited for the purposes of hunting and fishing. Exceptions are:
- (1) all-terrain vehicles (ATV) and outdoor power chairs used to transport handicapped hunters directly to and from their hunting location with written permission from the DPW Fish and Wildlife Manager;
- (2) hunters utilizing an ATV to retrieve a harvested deer on designated firebreaks. ATV use is prohibited off of designated firebreaks.

#### 2-7. Conduct

Hunting and fishing ethics are taken very seriously at Fort Campbell. Great efforts are made to provide outdoor opportunity, therefore the following laws are strictly enforced with zero tolerance and will result in immediate suspension of hunting and fishing privileges. No person shall:

- a. Use alcohol or illegal drugs on Fort Campbell property.
- b. Commit violent and abusive behavior towards Fort Campbell employees.
- c. Disrupt operations at fish and wildlife facilities.
- d. Interfere with any individual at fish and wildlife facilities.
- e. Interfere with the lawful take of wildlife resources.
- f. Drive, harass, or intentionally disturb any wildlife resources for purposes of disrupting lawful take of these resources.

#### 2-8. Disposition of Dead Wildlife

- a. Road-killed animals.
- (1) As provided by Kentucky and Tennessee law, turkey and white-tailed deer that are road-killed may, at the discretion of the DES, be given to the person driving the vehicle if the driver wants the animal.
- (2) At the discretion of the investigating officer, the animal may be added to the donated deer list and issued to any individual included on the donation request list. The

DPW Fish and Wildlife Program Manager develops and maintains the installation's donation list.

- (3) For management information or educational purposes, the DPW Fish and Wildlife Program Manager may request the removal and transfer of portions of road-killed wildlife, such as teeth, scales and embryos.
  - b. Legally Harvested Animals.
- (1) All harvested wildlife are considered Federal property until logged into the Fort Campbell Harvest Database and issued a harvest tag. All transported wildlife species must be equipped with a temporary harvest tag
- (2) All harvested wildlife become property of harvesting individual once properly reported in the iSportsman portal.
- (3) Harvested wildlife may be subjected to post harvest inspection or examination for research purposes. Samples of tissues and/or fluids may be taken by DPW Fish and Wildlife biologists, the game wardens, or the Fort Campbell Veterinary Services for developing information to improve conservation management, disease control or other official purposes.
- (4) Failure to provide fish or game for examination, when requested, may result in suspension of hunting and fishing privileges.

### 2-9. Concealed Weapons

Carry permits or concealed carry permits of any state are not recognized as authority to allow a person to carry a weapon on Fort Campbell at any time. Possession of handguns while hunting and fishing on Fort Campbell is prohibited.

#### 2-10. Miscellaneous Unlawful Activities

- a. No person shall litter or dump any type of waste materials on Fort Campbell.
- b. No person shall have an unleashed animal on Fort Campbell except for authorized hunting and training.
- c. No person shall take natural resources (plants, fungi, animals, and their parts) from Fort Campbell without obtaining proper authorization from the DPW Fish and Wildlife Program.
- d. No person shall introduce any plant, fungi, or animal on Fort Campbell. This includes bringing in seed source, transplanting or translocating any plant, fungi, or animal.
- e. No person shall enter Fort Campbell for purposes of locating, possessing, or removing artifacts or antiquities without written permission from Headquarters, 101st Airborne Division (Air Assault) and DPW Fish and Wildlife Program.
- f. POV operators must comply with CAM Regulation 190-5. Refer to Appendix D for unauthorized roads on Fort Campbell.
  - g. No person shall enter into off-limits areas, impact areas, or closed areas.
- h. No person shall take photos, videos, make notes, drawings, maps, or graphic representations of any portion of Fort Campbell unless proper authorization is obtained from Headquarters 101st Airborne Division (Air Assault). This includes use of trail cameras, video cameras, still cameras, cell phone cameras, or any other photo or video capturing devices. Exceptions are made only for photos of harvested game taken at unrestricted harvest locations.

- i. No person shall use drones or unmanned aerial vehicles of any type during any type of hunting and fishing activity. Drone usage at Fort Campbell is restricted or governed by other regulations promulgated by the Federal Aviation Administration, Department of Defense, the U.S. Army or Fort Campbell.
- j. No person shall enter Fort Campbell from private property for hunting and fishing activities.

#### 2-11. Violations and Enforcement

Violators of Federal and State game and natural resource laws are subject to prosecution before the U.S. Magistrate. Violators subject to the UCMJ are also subject to prosecution under that Code for violation of this regulation. Actions taken by the magistrate or commanders under the UCMJ will be in addition to the administrative suspension or revocation of hunting and fishing privileges. Violations and penalties are listed in Appendix C.

# 2-12. Revocation and Suspension Procedures

- a. Consumptive and non-consumptive activities provided through the iSportsman system on Fort Campbell are provided to Department of Defense personnel and the general public by the GC. These activities are privileges granted to qualified military and civilian personnel. These privileges may be revoked or suspended for violations of procedures of any content of this regulation or violations of other installation regulations while participating in hunting and fishing activities. Revocation or suspension will be in addition to any other administrative action, which may be taken by military authorities, or any judicial action that may be taken in the Federal Magistrate Court or Federal District Court.
- b. Individuals for whom revocation of these privileges is proposed will be notified by letter from the DPW Fish and Wildlife Program Manager. Suspensions of 60 days or less cannot be appealed. Individuals wishing to appeal suspension or revocation of privileges of 90 days or greater must do so in writing within 10 days of receipt of the revocation notice to the DPW, Environmental Division Chief. Appeals must contain reasons for the appeal.

# Chapter 3 Hunting on Fort Campbell

# 3-1. Weapon Restrictions

- a. No person shall take game animals with any weapon system except shotguns, muzzle loading rifles and shotguns, centerfire rifles, rim fire rifles, crossbows, compound bows, and traditional bows. **Note:** The Use of Full Metal Jacket Ammunition is Prohibited IAW State Regulations.
  - b. No person shall use full metal jacket or nonexpanding bullets on Fort Campbell.
  - c. No person shall use handguns on Fort Campbell.
  - d. No person shall use fully automatic weapons on Fort Campbell.
  - e. No person shall use any type air rifle or air bow on Fort Campbell.

- f. No person shall use any weapon type 30 minutes after official sunset or 30 minutes prior to official sunrise. Exception: Raccoon hunters are authorized to use rim fire rifles and 12 gauge or smaller shotguns while raccoon hunting at night.
- g. No person shall discharge any weapon from a vehicle on Fort Campbell. **Exception: Use of immobilized boat for waterfowl hunting purposes.**
- h. No person shall discharge any weapon within 100 feet of centerline of any an authorized road on Fort Campbell.
- i. No person shall discharge any weapon within 300 feet of any building, camping area, or military training on Fort Campbell.
- j. No person shall transport any loaded and/or uncased weapon (firearm or archery) in a vehicle on Fort Campbell. Firing caps or pan powder must be removed when transporting muzzleloaders.
- k. No person shall use firearms, fireworks, and/or explosives on Fort Campbell unless appropriate authorization is obtained from Headquarters, 101st Airborne Division (Air Assault) and/or the DPW Fish and Wildlife Program.
- I. No person, 15 years old and younger, shall possess a weapon of any type outside of the immediate control by an adult 21 years or older while hunting. Minors 15 years old and younger must remain within arm's reach of an adult 21 years or older while hunting.
- m. No person shall possess a firearm on Fort Campbell without completing a firearms registration from Fort Campbell Physical Security Program. All hunters are subject to CAM Reg 190-1, chapter 9, and AR 190-11 for registration of firearms.
- n. No person shall target shoot on Fort Campbell except on designated public ranges.
- o. No person shall use any weapon other than authorized archery equipment in areas designated as "Archery Only".
  - p. Authorized archery equipment are as follows:
- (1) any compound, traditional (recurve or longbow) with a rated pull of 45 pounds or more using arrows or bolts having nonpoisonous, non-explosive, and non-barbed broad heads not less than 7/8 inches wide only;
- (2) any crossbow having a draw weight of 100-200 pounds (no more or less), a working safety device, using arrows or bolts at least 16 inches long having nonpoisonous, non-explosive, and non-barbed broad heads not less than 7/8 inches wide only. Scopes or red dot sights are authorized for use on authorized crossbows as long as it does not emit any light towards the target (e.g. laser scopes).
- q. Archery equipment is authorized in "Shotgun and Muzzleloader" areas. No person shall hunt in a "Shotgun and Muzzleloader" area without following all regulations regarding fluorescent orange.
- r. Muzzleloaders must be .40 caliber or larger. Muzzleloaders can be percussion cap or flintlock. Muzzleloaders can only fire a single round ball, mini ball, maxi ball, or sabot slug. In-line muzzleloaders are authorized. Scopes or red dot sights are authorized for use on authorized muzzleloaders as long as it does not emit any light towards the target (e.g. laser scopes). Muzzleloaders using an electronic ignition are prohibited.
- s. Muzzle loading shotguns are authorized for turkey and all species described in small game hunting (see section 3-3.b.(5)).

t. For descriptions of authorized shotgun use on Fort Campbell, see each individual species' section under Big Game Hunting and Small Game Hunting.

# 3-2. General Hunting Regulations

- a. No person shall take any wildlife resource on FCMR without state and federal authorization under guidelines of U.S. Army and FCMR regulations (visit <a href="https://www.ftcampbell.isportsman.net">www.ftcampbell.isportsman.net</a> for seasons and bag limits).
- b. No person shall fail to make a reasonable effort to locate and retrieve wounded animals. All wounded animals must be immediately dispatched. Possession or transport of live wildlife, at any time, is prohibited.
- c. No person shall enter a hunting area until 90 minutes prior to official sunrise on the day of the hunt. Exception: Raccoon hunters are allowed to enter hunting areas at 90 minutes after official sunset and hunt their assigned area until 0300 (3:00AM) the following day.
- d. No person shall use artificial lights, motor vehicles, motorboats (except as immobilized hunting stands), or airplanes to take any wildlife resources on Fort Campbell. Exceptions: Raccoon hunters are authorized to use artificial lights while raccoon hunting and bullfrog hunters are authorized to use artificial lights while bullfrog hunting.
- e. No person shall use any form of bait on Fort Campbell. Bait is considered anything used to attract wildlife in consumable form. All salt, salt blocks, and minerals are considered bait. All grain or plant matter is considered bait. All consumable commercial attractants are considered bait.
- f. No person shall use or possess natural deer urine scents on Fort Campbell. Use of synthetic deer urine scents and other synthetic scent attractants are authorized in the form of aerosol, liquid applied to a drag line or hanging wick or piece of cloth. Applying any scents directly to the ground, emitting freely into the air, or applying to vegetation is prohibited.
- g. Entry into any restricted or off-limits area is prohibited. **Note: All Impact Areas Are Off Limits**. Entry into or removal of any item from an impact area, restricted area, or off-limits area is a violation of federal law.
  - h. All hunters must stay within the boundaries of their assigned hunting area.
- i. Use of elevated stands are authorized. All elevated stands are considered temporary and must be removed prior to leaving the assigned area. Use of screw in climbing pegs is prohibited.
- j. No person shall hunt from an elevated stand of any type without being properly secured with a safety harness.
  - k. No person shall obscure the sex or age of any harvested animal.
- I. No person shall use electronic game calls on Fort Campbell. **Exception: daytime use for coyote and bobcat hunting only.**
- m. Hunters may ride horses while squirrel, raccoon, quail, and rabbit hunting only. Hunters must dismount prior to discharging any weapon.
- n. No person shall hunt within the defined boundaries of the archery range and Lake Kyle Area (except waterfowl hunting when Lake Kyle is designated as open for waterfowl hunting).

- o. No person shall receive any form of compensation for the efforts of another to facilitate any type of hunting or harvest of any animal on Fort Campbell.
- p. No person shall waste a wild bird or wild animal that has been wounded or killed by that person while hunting. "Waste" means to intentionally leave a wounded or killed animal without making a reasonable effort to retrieve and render it for consumption or use.
- q. Migratory game bird hunters must abide by Federal Regulation 50 CFR 20.25 Wanton Waste of Migratory Game Birds. 50 CFR 20.25 is written as follows: No person shall kill or cripple any migratory game bird pursuant to this part without making a reasonable effort to retrieve the bird, and retain it in his actual custody, at the place where taken or between that place and either (a) his automobile or principal means of land transportation; or (b) his personal abode or temporary or transient place of lodging; or (c) a migratory bird preservation facility; or (d) a post office; or (e) a common carrier facility.

# 3-3. Big Game Hunting Regulations

- a. Deer Hunting.
- (1) Deer harvested on FCMR do not count towards Tennessee or Kentucky daily limits or season limits.
- (2) Hunters must possess appropriate Tennessee or Kentucky deer hunting licenses that authorize deer hunting and compliment weapon system being used (shotgun, muzzleloader, rifle or archery).
- (3) No person shall move harvested deer from the harvest location without affixing a temporary tag to the deer.
- (4) All deer must be checked in through the iSportsman portal before leaving FCMR. Harvested deer must be checked in within 90 minutes of official sunset. Specific days may require deer to be checked in at the big game check station, building 6645 101st Airborne Division Road, for data collection. Mandatory check in days will be designated annually with the hunting seasons and bag limits. All deer must be field dressed prior to transportation to FCFW check station when in person check in is required (i.e. all internal organs must be removed).
- (5) Archery, shotgun, muzzleloader, and rifle hunting may occur with respect to various state seasons but only within areas designated for each weapon system. Crossbows, compound bows, and traditional bows are authorized in "Archery Only" areas and "Shotgun and Muzzleloader" areas. Shotguns and muzzleloaders are prohibited in "Archery Only". Shotguns and muzzleloaders are only authorized for use in "Shotgun and muzzleloader" areas. Centerfire rifles will only be used in areas specifically designated as "Rifle" hunting areas. All hunters hunting in shotgun and muzzleloader or rifle areas must follow fluorescent orange regulations.
- (6) Hunters hunting in an authorized "Shotgun and Muzzleloader" areas or "Rifle" areas must wear a minimum of 500 square inches of blaze orange (daylight fluorescent orange) on their head and the upper portion of their body at all times while hunting. The blaze orange must be visible from the front and the back. Wearing a blaze orange hat and a blaze orange vest fulfills this requirement.
- (7) Authorized shotguns are as follows: any 20, 16, 12, or 10 gauge using ammunition loaded with rifled or sabot slugs only. Shotguns must be plugged or have a

magazine constriction so that shotguns can be loaded with no more than three shells at a time. Scopes or red dot sights are authorized for use on authorized shotguns as long as it does not emit any light towards the target (e.g. laser scopes).

- (8) Muzzleloaders must be .40 caliber or larger. Muzzleloaders can be percussion cap or flintlock. Muzzleloaders can only fire a single round ball, mini ball, maxi ball, or sabot slug. In-line muzzleloaders are authorized. Scopes or red dot sights are authorized for use on authorized muzzleloaders, as long as it does not emit any light towards the target (e.g. laser scopes). Muzzleloaders using an electronic ignition are prohibited.
- (9) Centerfire rifles, .223 caliber or larger, will be permitted IAW Tennessee and Kentucky hunting laws in specifically designated areas only (full metal jacketed ammunition is prohibited).
  - (10) Authorized archery equipment are as follows:
- (a) any compound, traditional (recurve or longbow) with a rated pull of 45 pounds or more using arrows or bolts having nonpoisonous, non-explosive, and non-barbed broad heads not less than 7/8 inches wide only;
- (b) any crossbow having a draw weight of 100-200 pounds (no more or less), a working safety device, using arrows or bolts at least 16 inches long having nonpoisonous, non-explosive, and non-barbed broad heads not less than 7/8 inches wide only.
- (c) Scopes or red dot sights are authorized for use on authorized crossbows, as long as it does not emit any light towards the target (e.g. laser scopes).
- (11) Archery equipment is authorized in "Shotgun and Muzzleloader" areas, but all regulations regarding fluorescent orange must be followed when entering a "Shotgun and Muzzleloader" area.
  - (12) No person shall use decoys while deer hunting.
  - (13) No person shall use electronic calls while deer hunting.
  - b. Turkey Hunting.
- (1) Use of any call that imitates or produces any sounds made by turkeys is prohibited outside of authorized turkey hunting.
- (2) No person shall move harvested turkeys from the harvest location without affixing a temporary tag to the turkey.
- (3) No person shall leave Fort Campbell property with a harvested turkey prior to reporting the harvest on the iSportsman portal. All harvested turkeys must be checked in prior to removal of any part of turkey (e.g. tail fan, legs, or beard) and prior to field dressing (i.e. removal of internal organs). Specific days may require turkeys to be checked in at the big game check station, building 6645 101st Airborne Division Road, for data collection. Mandatory check in days will be designated annually with the hunting seasons and bag limits
- (4) White turkeys may be harvested only during an authorized turkey hunting season.
  - (5) Authorized weapons for turkey hunting are as follows:
  - (a) shotguns .410, 28, 20, 16, 12, or 10 gauge using number 4 or smaller shot;
  - (b) muzzle loading shotguns using number 4 or smaller shot.
  - (c) Authorized archery equipment for turkey hunting is as follows:

- (1) any compound, traditional bow (recurve or longbow) with a rated pull of 45 pounds or more using arrows or bolts having nonpoisonous, non-explosive, and non-barbed broad heads not less than 7/8 inches wide only;
- (2) any crossbow having a draw weight of 100-200 pounds (no more or less), and a working safety device, using arrows or bolts at least 16 inches long having nonpoisonous, non-explosive, and non-barbed broad heads not less than 7/8 inches wide only.
- (3) Scopes or red dot sights are authorized for use on authorized crossbows, as long as it does not emit any light towards the target (e.g. laser scopes).
- (6) No person shall use dogs for hunting turkeys except during authorized Fall Turkey Season.
- (7) Turkey hunters may hunt in groups of three during any "Gun Only" Fall Turkey Season. All members of the hunting party must remain together at all times while hunting. Hunters must sign into an area individually during any spring turkey hunt with the exception of companions (see para 3-3.b(8) below).
- (8) Turkey hunters are authorized to have a "caller companion" accompany them on any Spring Turkey hunt. The companion must be checked in as the hunter's guest. Limit is one guest per hunter. Calling companions must have all required licenses and permits for turkey hunting on FCMR. Calling companions are prohibited from harvesting or assisting in direct act of harvest while assisting a hunter. Calling companions are prohibited from being checked in to any other activity or area while assisting a hunter.
- (9) No person shall use electronic decoys, electronic turkey calls, or electronic locater calls on FCMR.
- (10) Use of stationary decoys is authorized. Use of tail fans or decoys imitating strutting gobblers are authorized. Use extreme caution when attempting to use stationary or mobile (non-electronic) turkey decoys.
  - c. Feral Hog Hunting.
    - (1) No person shall trap, transport, or move feral hogs to or from Fort Campbell.
- (2) No person shall actively hunt, stalk, follow, attempt to lure, or otherwise pursue feral hogs on Fort Campbell. Report all feral hog sightings to the FCFW Program Manager at (270)798-9854.

# 3-4. Small Game Hunting Regulations

- a. Bullfrog Hunting.
  - (1) Bullfrogs may be hunted from boats.
- (2) Gigging and grabbing are only authorized methods of take when bullfrog hunting.
  - (3) Artificial lights are authorized for bullfrog hunting.
  - b. Coyote and Bobcat Hunting.
- (1) Coyote and bobcat hunters are authorized to check-in a hunting partner as a "guest" when checking in to an area in iSportsman. Limit is one guest per hunter. Guests must have their own area assignment and check-out of the area after the hunt. Guests must have all required licenses and permits for coyote hunting on FCMR. Guests are authorized to harvest coyotes.
- (2) No person shall hunt coyotes or bobcats 30 minutes after official sunset or 30 minutes prior to official sunrise.

- (3) Coyotes may be harvested on any big game or small game hunt. Bobcats may be harvested only during authorized coyote and bobcat hunts and deer hunts using authorized weapons for those hunts. Use or possession of electronic calls, handheld calls, mouth calls, or any other calls to mimic animals in distress or coyotes are prohibited on all hunts other than those opened by FCFW specifically for coyote and bobcat hunting. See Hunting Seasons and Bag Limits posted on Fort Campbell's iSportsman Portal for details on authorized coyote and bobcat only hunts.
- (4) Electronic and/or stationary decoys to mimic prey animals may be used only during hunts authorized for coyotes and bobcats. No person shall use decoys that resemble coyotes or bobcats.
- (5) No person shall use hunting dogs to pursue, chase, or facilitate harvest of coyotes and bobcats.
- (6) Harvested bobcats must be reported upon check out through the iSportsman portal. Failure to report harvested bobcats will result in suspension of hunting privileges.
- (7) Harvested coyotes must be reported upon check out through the iSportsman portal.
- (8) No person shall use any other weapons or traps to harvest coyotes and bobcats outside of the following weapon authorizations and restrictions:
  - (a) Any rim fire rifle is authorized.
  - (b) Authorized archery equipment is described in para 3-1.p.
  - (c) Authorized muzzleloaders equipment is described in para 3-1.r.
- (d) Muzzle loading shotguns loaded with shot with diameter of 0.20 inches up to 0.33 inches are permitted for coyote and bobcat hunting. Common shot sizes that fall within this range are: T shot, #4 buck shot, 0 buck shot, 00 buck shot. Muzzleloaders using an electronic ignition are prohibited.
- (e) Shotguns 12 gauge or 10 gauge using shot with diameter between 0.20 to 0.33 inches. Common shot sizes that fall within this range are: T shot, #4 buck shot, 0 buck shot.
  - c. Quail Hunting.
- (1) Quail hunters are authorized to hunt sunrise to sunset. Entry into the area prior to official sunrise is prohibited. All hunting ceases at official sunset. Hunters must be out of the hunting area NLT 30 minutes after official sunset. Hunters must submit a harvest report on the Fort Campbell iSportsman portal during check out procedures. NLT 90 minutes after official sunset.
- (2) Quail hunters must park within 35 feet of an authorized road, except at designated quail hunter parking areas. A digital location map is available on the Fort Campbell iSportsman portal and hardcopy maps are available at the FCFW Program at building 6645, 101st Airborne Division Road.
- (3) When seasons overlap, rabbit, squirrel, and woodcock may be harvested during authorized quail hunts using weapons authorized for quail hunting as long as harvested species are in season.
- (4) Special weapon authorizations and restrictions for quail hunting are as follows:
- (a) Use of .410 bore up to 12 gauge shotguns using number 6 or smaller are the only weapons permitted for quail hunting.

- (b) Shotguns used to hunt quail must be limited to hold no more than three rounds total (one in chamber and two in the magazine). Repeating shotguns capable of holding more than three shells must be plugged with a one-piece filler plug inserted inside the magazine in such a manner that it cannot be removed without disassembly of the shotgun.
- (5) Quail hunters must wear a fluorescent orange hat (at minimum) while quail hunting on Fort Campbell.
- (6) For information on obtaining an area for quail hunting refer to Fort Campbell's iSportsman Portal.
  - d. Rabbit Hunting.
    - (1) Rabbit hunters are allowed to hunt with or without the use of hunting dogs.
- (2) Rabbit hunters are authorized to hunt in groups of up to four. The party leader must check-in through iSportsman and add all party members to the area assignment and check-in. The party leader must be present during the hunt. All party members must have appropriate state licenses and permits issued through iSportsman for hunting on Fort Campbell. All party members must remain together at all times while rabbit hunting.
- (3) When seasons overlap, rabbit hunters may harvest squirrels and woodcock while rabbit hunting. To harvest woodcock, hunters must possess a Migratory Bird Permit.
  - (4) Harvest of quail is prohibited while rabbit hunting.
- (5) Rabbit hunters must wear a fluorescent orange hat (at minimum) while rabbit hunting on Fort Campbell.
  - e. Squirrel Hunting.
- (1) Squirrel hunters are authorized to hunt with or without the use of hunting dogs.
  - (2) Squirrel hunters are not required to wear any form of fluorescent orange.
- (3) Squirrel hunters are authorized to hunt in groups of up to three. The party leader must check-in through iSportsman and add all party members to the area assignment and check-in. The party leader must be present during the hunt. All party members must have appropriate state licenses and permits issued through iSportsman for hunting on Fort Campbell. All party members must remain together at all times while squirrel hunting.
- (4) When seasons overlap, squirrel hunters may harvest rabbits and woodcock while squirrel hunting. To harvest woodcock, hunters must possess a Migratory Bird Permit.
  - (5) The harvest of quail is prohibited while squirrel hunting.
  - f. Waterfowl Hunting.
- (1) Hunters must comply with Title 50, Code of Federal Regulation, Part 20. Hunters should also refer to Tennessee and/or Kentucky state regulations.
- (2) Waterfowl hunters are authorized to hunt in groups of up to four. The party leader must check-in through iSportsman and add all party members to the area assignment and check-in. The party leader must be present during the hunt. All party members must have appropriate state licenses and permits issued through iSportsman for hunting on Fort Campbell. All party members must remain together at all times while waterfowl hunting.

- (3) Waterfowl may be harvested only with .410 bore up to 10 gauge shotguns loaded with non-toxic shot no larger than T-Shot.
- (4) Shotguns used for waterfowl hunting are restricted to holding three or fewer shotgun shells. Shotguns capable of holding more than three shells must be plugged with a one-piece filler which is incapable of removal without disassembling the shotgun.
- (5) No person shall hunt waterfowl after official sunset or before 30 minutes prior to official sunrise.
- (6) Waterfowl hunters must park within 35 feet of an authorized road, except at designated waterfowl hunter parking areas. These designated parking areas can be seen on the Waterfowl Hunting Area Map located digitally on the iSportsman portal.
- (7) Electronic decoys may be used as long as they do not produce audio that mimics sounds produced by any species of waterfowl.

# 3-5. Handicapped Hunters and Handicap Hunting Areas

- a. Designated handicap hunting areas are for hunters with disabilities, including hunters who use wheelchairs and/or hunters with prosthetic limbs. These areas are allocated for handicapped hunters for deer and turkey hunting only. Proof of a handicapped parking placard or vehicle registration must be provided to the FCFW Program to obtain appropriate permits through iSportsman.
- b. Handicapped hunters and their companions hunting in training area 08HC must hunt from one of the provided hunting blinds while deer hunting. Still hunting, stalking, or firing a weapon from outside one of these blinds is prohibited, except if a hunter is tracking a wounded deer and an additional shot is needed for dispatching that animal. Turkey hunters may maneuver through training area 08HC while turkey hunting.
- c. Handicapped hunters using an ATV or outdoor power chair as an aid to hunt must possess a valid state issued handicap parking placard or handicap license plate. Handicap placards must be displayed in the vehicle prior to using ATV or outdoor power chair to enter hunting area.
- d. ATVs may be used to transport hunters with disabilities directly to and from their hunting locations. Companions are not authorized to ride on ATVs while assisting a handicapped hunter. Handicapped hunters may hunt from an ATV only if they are wheelchair bound hunters. Authorized handicapped hunters hunting from an ATV must have the engine turned off and the ATV immobilized.
- e. No person acting as an assisting companion for a handicapped hunter shall harvest any animal or possess a weapon for their own use. The purpose of the companion is to provide assistance to the disabled hunter while hunting. Companions may assist the hunter by carrying the hunter's unloaded weapon to and from the hunting location, locating a wounded animal, field dressing a harvested animal, and transporting the hunter to and from their authorized location. Unless searching for a wounded animal, companions must be within arm length of the hunter to provide immediate assistance if required. Companions must be registered through iSportsman and possess required state hunting license(s) and Fort Campbell hunting permit. Handicapped hunters wishing to have a companion must add the companion's name and permit number on all permits and check-ins. Companions are prohibited from being checked in to any other activity or area while assisting a handicapped hunter.

#### 3-6. Youth Hunters and Youth Hunts

- a. Individuals must be between nine and 17 years old to be considered Youth Hunters.
- b. Youth Hunters must possess a valid state issued hunter safety card and register through the Fort Campbell iSportsman Portal to obtain permits and access to hunting areas. Individuals less than 9 years of age may accompany an authorized adult 21 years of age or older on an authorized hunt. Youth less than 9 years old may not possess a weapon or harvest any game on Fort Campbell.
- c. Youth Hunters nine to 15 years old must be accompanied by an adult at least 21 years of age or older at all times while hunting on Fort Campbell. Youth Hunters nine to 15 years old wishing to hunt on Fort Campbell must be added to an Adult Hunter's iSportsman check-in.
- d. Youth Hunters 16-17 years old may hunt individually or with an adult. Youth Hunter 16-17 years old must check-in through the iSportsman Portal or be added to an Adult Hunter's check-in as mentioned in para 3-6.c.
- e. Youth Hunts will be offered exclusively for Youth Hunters. During these hunts, specified training areas will be assigned to Youth Hunters.
- f. Youth Hunters are required to follow all hunting and weapon regulations mentioned in previous sections.
  - g. Deer harvested on dedicated Youth Hunts do not count towards season limit.

# Chapter 4 Fishing on Fort Campbell

# 4-1. Fishing Regulations

- a. Anglers are required to have appropriate Tennessee or Kentucky fishing licenses and/or permits in combination with valid fishing permit issued by FCFW.
- b. Anglers that receive a free fishing license from either Tennessee or Kentucky will be offered a free fishing permit by FCFW.
  - c. Anglers 17 years old and younger will be offered a free fishing permit by FCFW.
- d. Fishing with live bait is authorized. No person shall use or possess carp or goldfish minnows as bait.
  - e. Fishing with artificial bait is authorized.
- f. No person shall take fish outside of conventional rod and reel (to include fishing rods without reels) on Fort Campbell. No person shall take fish by shooting, gigging, snagging, blasting, shocking, noodling, fish traps, baskets, jugs lines, limb lines, or trot lines.
- g. Use of landing nets to land a hooked fish and minnow nets for capturing live bait are both authorized. No person shall use any type of net to take fish on Fort Campbell.
- h. Anglers are limited to one rod while fishing for trout in trout streams. All other anglers are limited to three rods while fishing.
  - i. No person shall take or collect crayfish on Fort Campbell for any purpose.
  - j. Anglers may wade fish in trout streams while fishing.
  - k. No person shall ice fish on Fort Campbell.
- I. All anglers 15 years and younger must be accompanied by an adult 18 years or older.

- m. No person shall stock or introduce any fish species on Fort Campbell, unless authorized by the DPW Fish and Wildlife Program Manager.
- n. No person shall clean any fish in/and or around Lake Kyle, any trout stream, or any other area authorized for fishing on Fort Campbell.
- o. Anglers fishing for trout must possess a state trout fishing license and fishing permit issued by FCFW.
  - p. Trout stream locations are as follows:
    - (1) Fletcher's Fork Creek at Boiling Springs Road (Areas 2 and 6);
    - (2) Bridge over Little West Fork Creek at the west end of Clarksville Base;
    - (3) Mabry Road at Little West Fork Creek (Area 3);
    - (4) Kinser Pond in Clarksville Base.;
- (5) Bridge on 101st Airborne Division Road over Little West Fork Creek adjacent to golf course.
- q Anglers may check-in non-fishing companions through iSportsman as they complete their check-in process. Companion's full name and birth date must be provided. Companions are not required to possess a fishing license or Fort Campbell fishing permit. Companions are not authorized to fish while accompanying an angler.
- r. Use of boats, kayaks, and canoes is permitted for the purpose of fishing on all water bodies open to environmental recreation. Water bodies include:
  - (1) Training Area 19 Wetland;
  - (2) Training Area 28 Wetland;
  - (3) Joe Swing Quarry;
  - (4) Little West Fork Creek;
  - (5) Fletchers Fork;
  - (6) Piney Fork Creek;
  - (7) Saline Creek;
  - (8) Lake Kyle.
- s. All motor boats utilized for fishing must be registered in IAW Tennessee and Kentucky boating regulations.
- t. All boats must be properly equipped IAW Tennessee and Kentucky boating regulations (e.g. Personal Floatation Device, Fire Extinguisher etc.)

#### Chapter 5

# Other Consumptive and Non-Consumptive Activities

# 5-1. Dog Training and Field Trials

- a. Dog Training.
- (1) Dog trainers must possess a valid Tennessee or Kentucky issued hunting license and/or permit relative to the species pursued during dog training activities.
  - (2) Dog trainers must possess a state issued hunter safety certification.
- (3) Dog trainers must obtain an area assignment from FCFW or through iSportsman by checking into a "Game Scouting" area prior to using any area on FCMR for dog training.
- (4) Dog trainers pursuing raccoons may not possess any tree climbing gear, saws, hatchets, or axes. Additionally, dog trainers pursuing raccoons may not attempt

to climb any tree or cut any tree in an attempt to continue dog training. A treed raccoon shall be left treed.

- (5) Dog trainers may only pursue raccoons before and after spring turkey season upon area availability.
- (6) Dog trainers may only pursue quail 1 October 1 March upon area availability.
- (7) Dog trainers may use only firearms using blank ammunition. Possession of live ammunition is prohibited while dog training.
  - b. Field Trials.
- (1) All clubs or organizations wishing to sponsor a field trial must request approval for desired areas and dates through FCFW.
- (2) All individuals participating in a field trial event must obtain an area assignment from FCFW.
- (3) An annual field trial permit costing \$100.00 will be required by an individual, club representative, or organization representative. This permit is available on the iSportsman portal.

#### 5-2. Natural Resource Collection

- a. Resources authorized for collection include plant foliage, berries, nuts, mushrooms, and deer antler sheds. The collection of all other plants or plant parts is prohibited. **Note: Collection of ginseng is prohibited.**
- b. Resource collection is permitted only in areas open for hunting, game scouting, and general environmental recreation. Individuals must possess appropriate permit and area assignment.
- c. Resource collection requires check-in through the Fort Campbell iSportsman portal and a permit to be displayed in the vehicle window.
- d. Collection of firewood, plant foliage, berries, nuts, and mushrooms is limited to non-commercial use. Roots of plants may not be taken.
  - e. Collection of firewood is permitted IAW CAM Reg 200-2.
  - f. Collection of naturally shed antlers requires a permit authorizing deer hunting.
- g. Resource collection outside of assigned area may result in enforcement action or suspension of all outdoor activity privileges.

# Appendix C Violations and Penalties

All violations are subject to local, state and federal law. Individuals charged with violations are subject to a fine as well as suspension or revocation of hunting and fishing activity privileges. Longer suspensions or permanent revocation of privileges may be applied for violations based on severity. Violations may also involve criminal punishment and/or punishment under the Uniform Code of Military Justice. Multiple offenses may also result in a permanent bar from Fort Campbell.
